

## ANYVERSE™ Dataset Research Use License

Next Limit SL ("Next Limit") has developed a collection of annotated synthetic data images formatted to facilitate use for the purpose of training AI systems and neural networks ("ANYVERSE Dataset"). Next Limit is willing to license the use of this ANYVERSE Dataset pursuant to the terms of this ANYVERSE Dataset Research Use License ("License") to you only if you obtained the ANYVERSE Dataset directly from Next Limit, and only upon the condition that you accept all of the terms contained in this License. Exercising the rights granted to you below constitutes your agreement to be bound by the terms of this License. The term "you" and "your" means the individual using the ANYVERSE Dataset, or clicking "accept" or "agree" or otherwise demonstrating acceptance of this License, and thereby becoming bound by it, and the company or other legal entity represented by such individual or on whose behalf such individual acts, and all affiliates thereto.

### 1. Research Use License Grant

(a) Subject to and conditioned upon your compliance with the obligations of this License, Next Limit grants to you a worldwide, royalty-free, non-sublicensable, non-transferable, and non-exclusive copyright and database rights license, solely in furtherance of your Research Purpose, to download, reproduce and use the ANYVERSE Dataset. Next Limit grants no rights to and you shall not in whole or in part: (1) create "Derivatives" (defined as derivative works, modifications, adaptations, or compilations of the ANYVERSE Dataset or new images or labels derived from the ANYVERSE Dataset), or (2) display or distribute the ANYVERSE Dataset or Derivatives or (3) incorporate the ANYVERSE Dataset or Derivatives in any publicly available product, service, software or technology.

(b) The term "Research Purpose" means use solely in conjunction with (1) internal non-published research projects and (2) publicly available research publications and studies, access to which is not subject to payment. The term "Research Purpose" excludes without limitation the creation of Derivatives or use in connection with the development of any product, service, software or technology or any commercial undertaking. Next Limit offers ANYVERSE Dataset commercial use and Derivatives licenses per a separate license agreement. You shall not use the ANYVERSE Dataset for any non-Research Purpose except as separately agreed with Next Limit in a signed writing. Such activity is not licensed or authorized under this License, and if undertaken may result in pursuit of all available remedies for intellectual property rights (including copyright and database rights) infringement, the availability of which you hereby acknowledge.

(c) The ANYVERSE Dataset constitute Next Limit's confidential information protected by intellectual property laws and treaties, and is licensed, not sold. All rights not expressly granted in this section 1 are reserved to Next Limit. No other right or license will be implied by conduct or otherwise. Next Limit and/or its licensors retain all right, title and interest in the ANYVERSE Dataset and all associated intellectual property rights. Patents, trademark and servicemark rights, moral rights (including the right of integrity), publicity, privacy, and/or other similar personality rights are not licensed under this License.

(d) You shall not remove, destroy, deface or otherwise alter any legends, notices, statements or marks indicating Next Limit's ownership or the restrictions contained in this License.

(e) You shall not disclose or cause to be disclosed in whole or in part the ANYVERSE Dataset or any information contained therein ("Confidential Information") to any third party or use Confidential Information except as specifically authorized by this License. You shall protect the confidentiality of Confidential Information with the same degree of care, but no less than reasonable care, as you use to protect your own confidential information of like nature. You shall ensure that only your staff members with a strict and essential need to use Confidential Information will receive access to Confidential Information.

(f) The rights of this section may be exercised solely by your employees and contractors, for the sole purpose of enabling such staff to assist you in your research. You shall enter into written agreements with such staff

consistent with and no less protective of Next Limit and the ANYVERSE Dataset than the terms of this License prior to disclosure of ANYVERSE Dataset to such staff. Any services such staff perform in connection with the ANYVERSE Dataset must be solely for your benefit on a work-made- for-hire basis, and such staff shall assign sole ownership and exclusive rights of any work product in connection with ANYVERSE Dataset to you, without retaining use of, or any right, title or license of any kind to the ANYVERSE Dataset. All such staff shall return to you or destroy all copies of or materials containing the ANYVERSE Dataset in whole or in part upon the earlier of the end of such staffs' performance of services to you or termination of this License.

(g) You shall notify Next Limit immediately when you become aware of any breach or violation of this License, or of any potential or actual infringement of intellectual property rights related to the ANYVERSE Dataset.

2. Attribution. In a manner reasonably satisfactory to Next Limit, you shall cause to be conspicuously displayed in all public materials and websites referencing research conducted with the ANYVERSE Dataset a notice that the research was conducted using the ANYVERSE Dataset, with a link to the ANYVERSE Dataset website or anyverse.ai. You hereby consent to Next Limit listing the name and logo of your organization on the ANYVERSE Dataset website and other material describing the ANYVERSE Dataset.

3. Feedback. You agree that Next Limit may freely use and exploit in perpetuity any feedback, requirements, recommendations, ideas, bug fixes, reviews, ratings, benchmarks, comments, suggestions, or improvements, that you, or any employee or agent thereof, may at any time disclose or submit to Next Limit relating to the ANYVERSE Dataset for Next Limit's business purposes, including for product licensing, support and development, without any obligation or payment to you.

4. Data. You hereby consent to Next Limit's collection and use of anonymized data (including meta-data, analytical, diagnostic and technical data, and usage statistics) concerning or arising from your use of the ANYVERSE Dataset in order to provide the functionality of and improve the ANYVERSE Dataset, for product development and marketing purposes, to protect against spam and malware, and for verifying License compliance.

5. Updates. The ANYVERSE Dataset may update automatically. You agree to accept such updates subject to this License unless other terms accompany the updates. If so, those other terms will apply. Next Limit is not obligated to make any updates available, to continue making the ANYVERSE Dataset available for any period of time, or to provide any technical support of any kind.

6. Compliance. You shall comply with all applicable laws, rules, and regulations in respect of the use of the ANYVERSE Dataset.

7. Termination. Without prejudice to any other Next Limit rights or remedies, this License will automatically terminate if you fail to comply with its terms. In such event, you shall immediately destroy all copies and cease all use of the ANYVERSE Dataset. You acknowledge and agree that breach of this License, or any unauthorized use or distribution of the ANYVERSE Dataset, would cause irreparable harm to Next Limit, the extent of which would be difficult to ascertain, and that Next Limit will be entitled to seek without limitation immediate injunctive relief in any court of competent jurisdiction under the applicable laws thereof (and Next Limit's right to do so is not subject to arbitration). 10. **Severability; Waiver; No Agency; Entire Agreement.** If any of the provisions of this License are held to be in violation of applicable law, void, or unenforceable in any jurisdiction, such provisions will not affect the validity of the balance of the License, and such provisions are herewith waived or reformed to the extent necessary for the License to be otherwise enforceable in such jurisdiction. No waiver of any provision of this License will be deemed a further waiver or continuing waiver of such provision or any other provision, and Next Limit's failure to assert any right or provision under this License will not constitute a waiver of such right or provision. This License is the parties' entire agreement relating to its subject matter and supersedes all prior or contemporaneous oral or written communications, proposals, negotiations, understandings, representations and warranties and prevails over any conflicting or additional terms of any quote, order or other communication between the parties relating to its subject matter.

11. **Assignment.** This License may and shall not be assigned or transferred, or its rights or obligations assigned or delegated, by you, in whole or in part, including by way of merger or reorganization, acquisition or otherwise, without the prior written consent of Next Limit. Any assignment made in violation of this section will be void. Next Limit may freely assign this License without the necessity for consent.

12. **Governing Law; Arbitration.**

(a) This License will be governed by and construed under the laws of Spain. The choice of law rules of any jurisdiction, and the United Nations Convention on Contracts for the International Sale of Goods, will not apply. Any disputes between or claims brought by you or Next Limit arising out of or related to this License or the ANYVERSE Dataset (including tort as well as contract claims, and whether pre-contractual or extra-contractual, as well as the arbitrability of any disputes (subject to section 12(b) below) shall be referred to and finally settled exclusively by binding arbitration before the International Court of Arbitration in accordance with the Rules of Arbitration of the International Chamber of Commerce in effect at the time of arbitration except as inconsistent with this section. The arbitration will be conducted by telephone, on-line and/or based solely upon written submissions where no in-person appearance is required. If in-person appearance is required, such hearings will be held in New York City, New York if you reside in or are headquartered in North or South America, or Madrid, Spain, if you reside or are headquartered anywhere else. The arbitrator will apply the law specified in this section. All awards may if necessary be enforced by any court having jurisdiction. The existence of any dispute, the existence or details of the arbitration proceeding, and all related documents, materials, evidence, judgments and awards therein, shall be kept confidential. Except as required by law, no party will make any public announcements with respect to the proceeding or the award, except as required to enforce same. The parties hereby waive the right to a trial by jury and agree to only bring claims in an individual capacity and not as a plaintiff or class member in any purported class or representative proceeding. All disputes will be arbitrated only on an individual basis and not in a class, consolidated or representative action. The arbitrator does not have the power to vary these provisions. All claims (excluding requests for injunctive or equitable relief) between the parties must be resolved using arbitration in accordance with this section. Should either party file an action contrary to this section, the other party may recover lawyers' fees and costs associated with enforcing this section, provided that the party seeking the award has notified the other party in writing of the improperly filed claim, and the other party has failed to withdraw the claim in a timely fashion.

(b) Notwithstanding the foregoing, nothing in this section 12 will preclude the right and ability to bypass arbitration and file and maintain at any time an action for recovery of injunctive or provisional relief in any court of competent jurisdiction under the laws applicable thereto, and either party's right to do so is not arbitrable.

(c) A party prevailing in any litigation or arbitration related to this License or the ANYVERSE Dataset will be entitled, in addition to such other relief as may be granted, to an award of reasonable attorneys' fees.
